STRAIGHT PARTY TICKET

INSTRUCTIONS TO VOTER:

- To vote for all candidates of one party (a straight party ticket), touch the box to the left of the party.
- You may vote a split ticket by not selecting the box next to the party, but by selecting the box next to each candidate for whom you wish to vote.
- You may also vote a split ticket by selecting the box next to the party and then selecting the box next to the name of any candidate you choose of a different party.
- In any multi-seat race where a party is selected and you vote for candidates of another party, you must also select the box next to the name of any candidate you choose of the party for which you selected to assure your vote will count.
- If you wish to write in a candidate, where permitted, select the box next to the words "Write-in" and type the candidate's name on the line using the keyboard that will be displayed. Write-in votes are authorized only in certain races.
- A Straight party vote does not vote Nonpartisan Offices or other issues.
